Dear *South Carolina Law Review* Alumni:

On behalf of Volume 67, I am pleased to send you the *South Carolina Law Review*'s fall 2015 newsletter,. This newsletter will highlight some of the *Law Review*'s accomplishments and providing information about the Volume 67 Symposium and other events we have planned.

The Editorial Board for Volume 67 began work almost immediately in February to get a jumpstart on article selection. The Article Selection Committee was comprised of six student members—Caroline Gimenez, Jon LeCompte, Shanon Green, Chase Keibler, Keegan Miller and myself. The Article Selection Committee worked into July to find a diverse compilation of articles covering salient issues of the day. RI Smith, Jennie Rischbieter, and journal members also compiled a list of topics from which our 2L staff members have been drafting their notes to be considered for publication in our annual *Survey of South Carolina Law*.

Book 2 of Volume 67 will feature the white papers from the ABA Commission on the Future of Legal Services. USC Law's own Professor Elizabeth Chambliss is a member of the commission and chairs its "data" group. The white papers contain sixteen shorter

articles, each detailing an aspect of the delivery of legal services. The Commission will release their findings in March. The authors are from schools all over the country. We are excited to have the opportunity expand upon the prestige and reputation of the *South Carolina Law Review* on such a national scale.

This summer, the *Law Review* administered the Joint Journal Writing Competition, and we appreciate the work done by our Associate Editors-in-Chiefs, Mary Cothonneau Eldridge and Emily Dobson ,in managing the competition. At the conclusion of the competition, we were

pleased to select twenty-nine new members.

The *Law Review* welcomed Volume 67's new editorial staff during our August orientation, at which we were honored to hear from distinguished alumni. The Honorable Joseph F. Anderson, Jr. and

Dean Robert Wilcox delivered insightful remarks about their time on *Law Review* and emphasized the importance of our journal. Throughout the fall semester, both our second and third year members have worked very hard on behalf of the *Law Review*, but have also enjoyed building camaraderie between the classes.
